### Making of local law

- 1. Gladstone Regional Council (the "Council") has, by resolution dated the 6th day of June 2017, made each of—
  - (a) Animal Management (Amendment) Local Law (No. 1) 2017; and
  - (b) Animal Management (Amendment) Subordinate Local Law (No. 2) 2017; and
  - (c) Keeping of Animals (Amendment) Subordinate Local Law (No. 1) 2017.

#### Local law amended

- 2. The local law and subordinate local laws referred to in paragraph 1 amend a local law and subordinate local laws as follows—
  - (a) Animal Management (Amendment) Local Law (No. 1) 2017 amends Local Law No. 2 (Animal Management) 2011; and
  - (b) Animal Management (Amendment) Subordinate Local Law (No. 2) 2017 amends Subordinate Local Law No. 2 (Animal Management) 2011; and
  - (c) Keeping of Animals (Amendment) Subordinate Local Law (No. 1) 2017 amends Subordinate Local Law No. 1.5 (Keeping of Animals) 2011.

## **Authorising local law**

The local laws that authorise the making of the subordinate local laws referred to in paragraph 1 are as follows—

- (a) Local Law No. 2 (Animal Management) 2011 authorises the making of Animal Management (Amendment) Subordinate Local Law (No. 2) 2017; and
- (b) Local Law No. 1 (Administration) 2011 authorises the making of Keeping of Animals (Amendment) Subordinate Local Law (No. 1) 2017.

#### Purpose and general effect

- 2. The purpose and general effect of the local law and subordinate local laws referred to in paragraph 1 is as follows—
  - (a) Animal Management (Amendment) Local Law (No. 1) 2017 regulates the supply of cats, including the publication of advertisements about the supply of cats; and
  - (b) Animal Management (Amendment) Subordinate Local Law (No. 2) 2017 prescribes persons for cat supply exception purposes and prescribes a requirement for an approval to keep animals; and
  - (c) Keeping of Animals (Amendment) Subordinate Local Law (No. 1) 2017, prescribes documents and materials that must accompany an application for a cat breeder approval, criteria for the grant of a cat breeder approval and conditions that will ordinarily be imposed on a cat breeder approval.

# **Anti-competitive provision**

3. Each of the local law and subordinate local laws referred to in paragraph 1 contain an anti-competitive provision.

## Consolidated version of local law

- 4. Council has, by resolution dated the 6<sup>th</sup> day of June 2017, adopted a consolidated version of each of the following—
  - (a) Local Law No. 2 (Animal Management) 2011; and
  - (b) Subordinate Local Law No. 2 (Animal Management) 2011; and
  - (c) Subordinate Local Law No. 1.5 (Keeping of Animals) 2011.

- 5. Copies of each of the local law and subordinate local laws referred to in paragraph 1 and the consolidated versions of the local law and subordinate local laws referred to in paragraph 4 may be—
  - (a) inspected and purchased at Council's public office at 101 Goondoon Street, Gladstone; and
  - (b) viewed by the public on the website of the Department of Local Government.
