Making of subordinate local law

- 1. Gladstone Regional Council (the "Council") has, by resolution dated the 7th day of March 2017, made each of—
 - (a) Animal Management (Amendment) Subordinate Local Law (No. 1) 2017; and
 - (b) Community and Environmental Management (Amendment) Subordinate Local Law (No. 1) 2017; and
 - (c) Local Government Controlled Areas, Facilities and Roads (Amendment) Subordinate Local Law (No. 1) 2017.

Subordinate local law amended

- 2. The subordinate local laws referred to in paragraph 1 amend subordinate local laws as follows—
 - (a) Animal Management (Amendment) Subordinate Local Law (No. 1) 2017 amends Subordinate Local Law No. 2 (Animal Management) 2011; and
 - (b) Community and Environmental Management (Amendment) Subordinate Local Law (No. 1) 2017 amends Subordinate Local Law No. 3 (Community and Environmental Management) 2011; and
 - (c) Local Government Controlled Areas, Facilities and Roads (Amendment) Subordinate Local Law (No. 1) 2017 amends Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2011.

Authorising local law

- 3. The local laws which authorise the making of the subordinate local laws referred to in paragraph 1 are as follows—
 - (a) Local Law No. 2 (Animal Management) 2011 authorises the making of Animal Management (Amendment) Subordinate Local Law (No. 1) 2017; and
 - (b) Local Law No. 3 (Community and Environmental Management) 2011 authorises the making of Community and Environmental Management (Amendment) Subordinate Local Law (No. 1) 2017; and
 - (c) Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2011 authorises the making of Local Government Controlled Areas, Facilities and Roads (Amendment) Subordinate Local Law (No. 1) 2017.

Purpose and general effect

- 4. The purpose and general effect of the subordinate local laws referred to in paragraph 1 is as follows—
 - (a) Animal Management (Amendment) Subordinate Local Law (No. 1) 2017 identifies where animals are prohibited in public places and 1 dog off-leash area; and
 - (b) Community and Environmental Management (Amendment) Subordinate Local Law (No. 1) 2017 defines the expression "vermin" and identifies declared local pests; and

(c) Local Government Controlled Areas, Facilities and Roads (Amendment) Subordinate Local Law (No. 1) 2017 regulates the removal of waste bins from road and footpath areas after the collection of waste and the driving of vehicles on Agnes Water Main Beach.

Anti-competitive provisions

5. None of the subordinate local laws referred to in paragraph 1 contains an anti-competitive provision.

Consolidated version of subordinate local law

- 6. Council has, by resolution dated the 7th day of March 2017, adopted a consolidated version of each of—
 - (a) Subordinate Local Law No. 2 (Animal Management) 2011; and
 - (b) Subordinate Local Law No. 3 (Community and Environmental Management) 2011; and
 - (c) Subordinate Local Law No. 4 (Local Government Controlled Areas, Facilities and Roads) 2011.

Inspection

- 7. Copies of the subordinate local laws referred to in paragraph 1 and the consolidated versions of the subordinate local laws referred to in paragraph 6 may be—
 - (a) inspected and purchased at Council's public office at 101 Goondoon Street, Gladstone; and
