

## NOTICE OF MAKING OF LOCAL LAW

### *Local Government Act 2009*

#### Gladstone Regional Council (Making of Local Law) Website Notice (No. 1) 2016

#### **Making of subordinate local law**

1. Gladstone Regional Council (the “Council”) has, by resolution dated the 6th day of December 2016, made each of—
  - (a) *Commercial Use of Local Government Controlled Areas and Roads (Amendment) Subordinate Local Law (No. 1) 2016*; and
  - (b) *Installation of Advertising Devices (Amendment) Subordinate Local Law (No. 1) 2016*; and
  - (c) *Operation of Caravan Parks (Amendment) Subordinate Local Law (No. 1) 2016*.

#### **Subordinate local law amended**

2. The subordinate local laws referred to in paragraph 1 amend subordinate local laws as follows—
  - (a) *Commercial Use of Local Government Controlled Areas and Roads (Amendment) Subordinate Local Law (No. 1) 2016* amends *Subordinate Local Law No. 1.2 (Commercial Use of Local Government Controlled Areas and Roads) 2011*; and
  - (b) *Installation of Advertising Devices (Amendment) Subordinate Local Law (No. 1) 2016* amends *Subordinate Local Law No. 1.4 (Installation of Advertising Devices) 2011*; and
  - (c) *Operation of Caravan Parks (Amendment) Subordinate Local Law (No. 1) 2016* amends *Subordinate Local Law No. 1.8 (Operation of Caravan Parks) 2011*.

#### **Authorising local law**

3. *Local Law No. 1 (Administration) 2011* authorises the making of each of the subordinate local laws referred to in paragraph 1.

#### **Purpose and general effect**

4. The purpose and general effect of the subordinate local laws referred to in paragraph 1 is as follows—
  - (a) *Commercial Use of Local Government Controlled Areas and Roads (Amendment) Subordinate Local Law (No. 1) 2016* prescribes minimum standards for the undertaking of the prescribed activity of footpath dining which, if complied with, replace the need for the person operating that activity to apply to Council for the grant of an approval;
  - (b) *Installation of Advertising Devices (Amendment) Subordinate Local Law (No. 1) 2016* prescribes criteria for the installation, erection and display of various categories of advertising device; and
  - (c) *Operation of Caravan Parks (Amendment) Subordinate Local Law (No. 1) 2016* prescribes minimum standards for the undertaking of the prescribed activity of the operation of a caravan park which, if complied with, replace the need for the person operating the prescribed activity to apply to Council for the grant of an approval.

#### **Anti-competitive provisions**

5. Each of the subordinate local laws referred to in paragraph 1 contains anti-competitive provisions.

### **Consolidated version of subordinate local law**

6. Council has, by resolution dated the 6<sup>th</sup> day of December 2016, adopted a consolidated version of each of—
- (a) *Subordinate Local Law No. 1.2 (Commercial Use of Local Government Controlled Areas and Roads) 2011*; and
  - (b) *Subordinate Local Law No. 1.4 (Installation of Advertising Devices) 2011*; and
  - (c) *Subordinate Local Law No. 1.8 (Operation of Caravan Parks) 2011*.

### **Inspection**

7. Copies of the subordinate local laws referred to in paragraph 1 and the consolidated versions of the subordinate local laws referred to in paragraph 5 may be—
- (a) inspected and purchased at Council's public office at 101 Goondoon Street, Gladstone; and
  - (b) viewed by the public on the website of the Department of Local Government.
