# **G/1. MAYORAL STATEMENT OF CURRENT ISSUES**

Our Gladstone Regional Drought Appeal reached \$40,000 thanks to the funds raised at the Christmas Street Party, Santos GLNG Mayor's Carols, our Super Rugby game, Australia Day and donations made by our major industry raising \$32,000 with a further \$8000 donation to the appeal by the Salvation Army. The \$40,000 is going to be spread across the Gladstone Region to our primary producers so I am encouraging our primary producers to jump on Council's website that will be live tomorrow where a link will be attached to submit an expression of interest. I want to give a shoutout to the Department of Agriculture as they helped us to get to this point. If you know someone who is a primary producer in the Gladstone Region please encourage them to apply, we understand they are a proud and resilient bunch however it is a hand up not a hand out. Council wants to make sure they apply so please give our primary producers a push and aid them to fill out the form as that money could assist with them with necessary production costs. We want to see the money go out as soon as possible so the closing date is 31 July 2020. Roadshows with the Salvation Army will be held across the region beginning in Rosedale going to Miriam Vale, the Boyne Valley, Calliope and to Mt Larcom to make sure the funds do get out into the community. The Salvation Army will be able to provide additional support and information for our primary producers. Council will also provide information around potential support available from State and Federal Government. Thank you to our community, industry partners and Salvation Army for raising the \$40,000 for our community and Gladstone Region primary producers.

It is great to see things in the Region reopening and getting back to normal, Gladstone Chamber of Commerce and Industry is now having face to face meetings again and the DCTC have a meeting on Wednesday. The Gladstone Central Committee on the Ageing are hosting a morning tea this morning which is great to see our local seniors getting out and about, unfortunately we are unable to attend today due to the Council meeting however I am sure they will have a fantastic day. I would like to mention that the Rosella Street Shop has reopened which may seem small however the shop has been closed for a long time and it is fantastic to see it reopen. If you are driving along Rosella Street pop in and visit them. It's great to see our local businesses opening especially when they have been closed for this extended period of time.

Importantly, our Premier of Queensland Annastacia Palaszczuk visited Gladstone recently to do a tour of the new Accident and Emergency Unit at the Gladstone Hospital which was a \$42,000,000 build and 20 years in the making. Member for Gladstone Glenn Butcher was also there during the visit. The floor space has increased by approximately double and facility is far superior to what we have had in the past and future proofs the Gladstone Hospital for a long time to come. The Premier also announced that \$5,000,000 will be provided to fund 30 new positions for the Gladstone Hospital, so not only do we have new Accident and Emergency Unit but also the staff to go with it. This funding provides for administration staff, doctors, nurses and specialists which is fantastic news so thank you to Member for Gladstone Glenn Butcher who fought very hard for this and the Premier for announcing this. During the Premier's time in the region she also visited the Gladstone Aquatic Centre so she could see the facility prior to upgrades funded by the COVID-19 Works for Queensland. The COVID-19 Works for Queensland is funding of about \$5,000,000 for Council which will be used for the Gladstone Aquatic Centre and also other projects in the region so this money can be spread throughout the region, it will be fantastic to see these upgrades take place very soon.
