As the repercussions of COVID-19 could go on for many, many years and we are unable to foresee when the tourism industry will bounce back and once again provide an income, let alone provide us with a sufficient income to maintain household bills, rates and other expenses, we believe this is a valid request and ask Gladstone Regional Council for careful consideration in this matter.

We believe that Gladstone Regional Council sees the value of our business to the local economy, once we will be trading again and we hope for a positive outcome in these uncertain times!
