Councillor Rick Hansen congratulated the Baffle Creek Car and Bike Muster group for their successful meeting recently and mentioned that Councillor Muszkat was a big part of that event.

Councillor Natalia Muszkat wished the QCWA Mt Larcom branch a wonderful birthday and mentioned that the Mt Larcom branch celebrated 90 years on the weekend. Cr Muszkat further mentioned that it was inspiring and fulfilling to see communities such as Mt Larcom embrace a group of hard working women such as the QCWA Mt Larcom branch.

Councillor Glenn Churchill mentioned that he attended the Gladstone Regional Council's Youth Council meeting last night and noted that they were a wonderful working group of young people. Cr Churchill advised that the youth council is focusing on safety within our city and within our region and the diversity of people, recognising that younger, and older, people are moving into our region and as a result of that understanding the inclusion and feeling of being safe in our community.

Mayor Matt Burnett reaffirmed Cr Muszkat's comments regarding the QCWA Mt Larcom branch celebrating their 90th birthday and further acknowledged the 90 years of support for the local community there. Mayor Burnett mentioned that the street parade was well attended and it was great to see the community out and about and supporting the QCWA branch. Mayor Burnett celebrated the collective 110 years of service of Dawn O'Dowd and Jean Peters to the QCWA Mt Larcom, noting that all the ladies there do an amazing job, however Dawn and Jean have made a significant contribution, with Jean celebrating 40 years and Dawn celebrating 70 years.

Mayor Burnett mentioned Sean Dillon, Mayor of Barcaldine Regional Council referencing the Bush Councils Conference that was scheduled to be held there today, with councillors from around the state scheduled to attend. Mayor Burnett highlighted that every hotel and motel had been booked out and a camp had been setup for delegates attending the conference however unfortunately due to the COVID situation in south east Queensland, that conference has been postponed to next year.
