## **G/1. MAYORAL STATEMENT OF CURRENT ISSUES**

I was recently in Canberra for the Australian Local Government Association (ALGA) Board meeting. ALGA represents all 537 councils in the country on issues that are important to us, most importantly financial assistance grants and ensuring local councils and local communities get their fair share back from the Federal Government. The financial assistance grants were the highest priority agenda item along with local roads and community infrastructure program, which we did receive funding in the Federal Budget, which is good news for local government. Unfortunately, financial assistance grants weren't increased, but we will continue to fight for that one percent of commonwealth taxation to come back to local councils in Australia.

We held the Mayor's Youth Breakfast last Friday, 1 April 2022, at the Gladstone Entertainment Convention Centre. Well done to the whole team who organised that event. There were approximately 90 young people registered and nominated and approximately 70 people at the event. It was fantastic to acknowledge our youth, the next generation of the Gladstone Region. They travelled from right across the region into the city to be a part of that event. We have some amazing young people in our community, whether it is in sporting, volunteering, employment, cultural, musical, there were so many inspirational young people, and it was fantastic to acknowledge them as well.

The Tannum Crab Classic was held recently and shout out to the team there for doing an amazing job and keeping that event going with proceeds supporting suicide prevention and child bullying.

This weekend is the Boyne Valley Country Music Camp Out. If you haven't got your tickets, get in and get them, if they haven't already sold out. I'll be heading up Friday. Cr Desley O'Grady and Cr Glenn Churchill will also be attending. Councillors and everyone watching on live stream, check out the Boyne Valley Country Music Camp Out in Ubobo this weekend.

It's Easter in Gladstone. Starting on Thursday 14 April 2022 we have our Gladstone Harbour Festival Opening Night on the Gladstone Ports Corporation (GPC) Marina Stage. It's all for the families - we have Peter Rabbit 2, the Smurfs, Dinosaur Train and of course wrapping up with fireworks. It is the greatest time in the world to be in Gladstone at Easter time. On Friday 15 April 2022 we have 7 Whales in Moscow and Indigo Electric playing live on stage. On Saturday 16 April 2022 we have RedThorn and people might remember The Koi Boys from the Mayor's Ball a few years back, they'll be here on Saturday night and fireworks again. More entertainment on the Marina Stage on Sunday 17 April 2022, including The Elton John Experience and more fireworks. It's good to see the festival still going strong. It is free for all to attend and enjoy.

This year we have our Brisbane to Gladstone Village back as well. Opening on Thursday 14 April 2022 night with the B2G Village Opening Party. ## **G/5. COUNCILLORS REPORT**

Councillor Chris Cameron mentioned that on the 23 March 2022, he attended the official launch of the Tropical North Queensland Drought Hub Fitzroy Node which is a Federal Government initiative funded through the Future Drought Fund and facilitated through James Cook University. Cr Cameron advised that the Fitzroy Node was the last of the six (6) nodes to be established which include the Wet Tropics Node, Gulf Savannah Node, Gulf of Carpentaria Node, Mackay & Whitsundays Node and Burdekin Node. Cr Cameron noted that the Fitzroy area runs from Nebo to the north, Wandoan to the south, Clermont to the west, Gladstone to the east and some island areas. Cr Cameron advised that the project was about gathering data on each of the nodes, collating and analysing the data for management and facilitation of addressing the effects of drought. Cr Cameron noted some interesting statistics that have been collected regarding the Fitrzoy node, including there is 3.2 million head of cattle; 77% of all active coal mines; 5,178 native species; 8,534 wetlands; 79% of the land is managed by farmers and graziers; and there are 224 rare or threatened species. Cr Cameron advised that he expressed interest in continuing on with the project as a participant in the working group.

Councillor Chris Trevor acknowledged the upcoming federal election and noted that this meeting could be Mayor Burnett's last meeting and wished all candidates the very best of luck in the election. Cr Trevor noted it was very brave to put your hand up and serve the public in the public interest. Cr Trevor congratulated Mayor Burnett and all candidates who are putting their name forward in the upcoming federal election and wished them all the best.

Mayor Burnett announced that he will be taking a leave of absence as Mayor of Gladstone Regional Council from Monday 18 April 2022 as it is the last date for the federal election to be called and noted that no election has been called as yet. Mayor Burnett advised that the date to commence his leave of absence was chosen as it has been tradition that the Mayor and Councillors have responsibilities over the Easter period, particularly around the Brisbane to Gladstone Yacht Race and therefore he will fulfil the duties as Mayor up until and including Easter Sunday and from Easter Monday Mayor Burnett will take a leave of absence for the election period. Mayor Burnett acknowledged that today could be his last Council meeting and noted he has spent 22 years representing the local community in Gladstone. Mayor Burnett reflected on the events and achievements of the Council over the years including the return of the Gladstone Area Water Board dividends; preventing the Gladstone Port from being sold; building the PCYC, library and entertainment centre; building the community centre at Agnes Water; building skate parks and pump tracks; re-building Bunting Park, which is an amazing facility for Calliope; Alf Larson Park, which has revitalised Miriam Vale; Lions Park in Gladstone, which is a fantastic facility for everybody to use; and the Philip Street Families and Communities Precinct. Council has seen the raising of the Aboriginal and Torres Strait Islander flags; the development of New Auckland Place, Edenvale and Settlers; and the development of the Heritage Retirement Village in Telina; the construction of three (3) LNG plants; Rio Tinto stages 1 and 2; WICIT; Northern Oil; and now Alpha HPA and an emerging hydrogen industry. Mayor Burnett further acknowledged the group of mayors across Central Queensland for securing funding for the Inland Rail Project and the exciting events that Council has been able to deliver including the first NRL game to Gladstone; the Queensland Reds; the Brisbane Roar; the Cultural Immersions Festival; adoption of a Reconciliation Action Plan (RAP); Luminous and many more. Mayor Burnett acknowledged that it is an honour and pleasure to work alongside the councillors and if fortunate enough to be elected as Federal Member for Flynn, he will continue to deliver right across the community and if unsuccessful at the election, he will be back ready to continue serving the Gladstone Region as Mayor.
