G/5. COUNCILLORS REPORT

Councillor Desley O'Grady mentioned that when the feasibility study for the Boyne Burnett Inland Rail Trail was completed, there were three sections that were identified and that the Doors Range Tunnel section was opened last year and this Saturday 10 September 2022 the Burnett River Bridges section will be opened. Cr O'Grady noted that the Burnett River Bridges section was located between Mundubbera and Mount Debateable with the distance just over 30kms one way (or Mount Debateable to Reid's Creek section at 6kms). Cr O'Grady mentioned that at the opening this weekend, it was expected that there would be over 500 people attending with everybody invited to attend the opening of the Boyne Burnett Inland Rail Trail Burnett River Bridges sections. Cr O'Grady noted that the official opening was scheduled for 11:00am and with a fun run held at 8:30am and food provided by Little Athletics Gayndah and Rotary Club Mundubbera. Cr O'Grady mentioned that the towns are very excited and that most of the accommodation in Mundubbera and Gayndah are booked out.

Councillor Chris Cameron provided a statement on behalf of the Capricorn Pest Management Group (CPMG):

'The Capricorn Pest Management Group (CPMG) in conjunction with the Australian Government's Reef Trust and the Fitzroy Basin Association are holding three Feral Pig Landholder engagement workshops to address the issues and problems concerning the Feral Pig populations in Central Queensland.

The Australian Government have funding available to assist in the control of the feral pig population and the damage they cause and some diseases they can spread. However the Australian Government are of the opinion that Central Queensland does not have a serious problem with the feral pig population, consequently there is no funding available to Central Queensland. There is a serious problem with feral pigs in our region and disease such as tuberculous and elliptocytosis have been found in feral pigs in our region. Both these diseases can be fatal to animals and humans.

The aim of these workshops is to bring together landholders, pest management contractors, feral pig hunters and shooters, and anyone who has an interest in the control and management of feral pigs in our region to be a contributor of information on the sighting or and estimate numbers of feral pigs and the area of the sighting. This recording will be achieved by using a free download app 'FERALSCAN', which can be sent to a central database to be collated with a view to convince the Australian Government that Central Queensland does have a feral pig population and needs to be considered for any available funding to control the feral pig population.

There are three workshops starting on Monday 10 October 2022 at Kalapa Hall, Black Mountain Road, between Gracemere and West Wood, 8:30am to 2:00pm (approximately). Tuesday 11 October 2022 at Banana Shire Council Dee and Don Room, 62 Valentine Plans Road, Biloela, 8:30am - 2:00pm (approximately). Wednesday 12 October 2022 at Ubobo Hall, 5 Railway Terrace, Boyne Valley 8:30am -2:00pm (approximately). The presenters will be Peter West, FeralScan: Coordinator and Invasive Species Officer NSW Department of Primary Industries and Tyrone Davis, Tracker Traps. Attendees will be given the tools to record Feral Pig activity on their properties and learn to manage and reduce the impacts of these pests. Each attendee will go into a draw to win a free Tracker Traps Panel Trap and three bags of Tracker Traps grain mix. One winner for each location. Attendees must be in attendance to be eligible and have the FeralScan app downloaded on their phone or device. Morning tea and lunch will be provided.

Further workshops will be allocated after the success and interest of the first three workshops are accessed.'
