G/0.3.3. MESSAGES OF CONDOLENCE

Councillor Desley O'Grady passed on condolences to Gassan Sangari who passed away earlier in the month. Cr O'Grady mentioned that a lot of people know Gassan as 'kebab man', he had Kebab Heaven which he went to many different organisations around the region and not for profit groups selling his kebabs. Cr O'Grady mentioned that Gassan originally came to Agnes Water and Seventeen Seventy area and had Latino's and then moved to Gladstone. Cr O'Grady passed on condolences to the family and friends of Gassan.

Councillor Rick Hansen mentioned that Peter Turich very sadly passed away last week. Peter Turich was born in Gladstone on 10 February 1951. Peter was one of two children, with his sister Margeret, to Aileen and Godfrey Turich. The family lived on Auckland Hill during Peter's early years before moving to Glenlyon Street. On trips out to Heidelberg (the family property) with Godfrey, Peter developed an affinity and love of the land. Like his father, Peter had a passion for tennis and enjoyed success in the juniors and as a result it was decided that he would move to Brisbane to complete year 11 and 12 and play tennis on the Brisbane Circuit. He then attended Teachers College at Kelvin Grove.

Peter took his first teaching placement at Gladstone West in 1970. It was also at that time that Peter started playing cricket and he became a foundation member of the newly formed 'The Glen Cricket Club', a team that Peter captained to a record 7 consecutive A grade premierships. Peter would later return to become the Principal of West State School for 15 years after spending time teaching at Clinton, Central, Boyne Island, South and Kin Kora Schools.

Peter met his future wife Judy from Bowen in August 1975. In December 1976, Peter and Judy were married and made their home on the family property at Benaraby. Peter and Judy had six children, Joanna, Louise, Andrea, Matthew, Peter and David. Many years were spent with the children at swimming, dancing, speech and drama, singing, eisteddfod, music, basketball, football and cricket. As the last of their children left home to pursue their careers, Peter decided to combine his two passions of 'Property Development' and Heidelberg. In May 2012, earthworks commended on Gladstone's largest residential development, known as Riverstone Rise. Peter retired as the Principal of Gladstone West State School in 2012 closing the chapter on a 42 year career with Education Queensland. He threw himself into the development, cattle work, running the property, travel and family commitments; including his 16 grandchildren.

Peter was incredibly generous with his time, especially for those seeking his advice. His calm and thoughtful nature, coupled with his excellent communication skills made him someone people gravitated to naturally. Peter always brought with him his positivity and happiness. He was a humble man who sought to live a simple life, based on his faith and a well calibrated moral compass. He was a statesman and a true gentleman. On behalf of Council, Cr Hansen passed on sincere condolences for Peter's passing to Judy and the family. May he rest in peace.

Mayor Matthew Burnett passed on a message of condolence for Uncle Richie Johnson, Gooreng Gooreng Elder. Uncle Richie passed away on the weekend and Mayor Burnett advised that he has permission from the family ahead of the funeral to have this message of condolence. Mayor Burnett mentioned that Uncle Richie was born in Gladstone on 16 March 1951 and grew up in the family home, which is where Gladstone State High School is now, it was their family property and they were there for many years before they moved to Barney Point and moved into a commission house there which Aunty Jacqueline (Jackie), his sister still lives today, so it has been part of the family for a very long time. Mayor Burnett mentioned that Uncle Richie's brothers and sisters include Judith, Merle, Jackie, Valda, Lindsay (who passed away recently), Julie, Neola and Marilyn and noted that there may be others that are not known by the Mayor. Mayor Burnett noted that he knows the family very well and that their families are very close. Mayor Burnett mentioned that Uncle Richie has 3 daughters, Nonnie, Naomi and Annie and sent condolences to the daughters. Mayor Burnett noted that Uncle Richie has 11 grandchildren and 4 great grandchildren. Mayor Burnett mentioned that Uncle Richie's family connections to the community go back generations. Mayor Burnett acknowledged that Uncle Richie was always participating in Council's welcome to country ceremonies and has participated in many events across the Region for many years, including the Seventeen Seventy Festival where the Gooreng Gooreng play an important part. Mayor Burnett noted that Uncle Richie was passionate about his culture and his community and made sure that the stories from his parents and grandparents lived on through the next generation. Mayor Burnett noted that Uncle Richie was now joining his wife Morag who passed away in 1990's and further mentioned that he raised his daughters pretty much by himself following her passing and sent deepest condolences to his family. Mayor Burnett encouraged everyone to watch the "My Priceless Past" video which Uncle Richie recorded just before he passed. May he rest in peace.

Councillor Glenn Churchill paid tribute, on behalf of Council and all the communities of the Region, for the sad deaths of two brave Queensland Police Officers, Constable Rachel McCrow and Constable Matthew Arnold and a community citizen, Alan Dare. Cr Churchill mentioned that last week was a dark day in the history of the Queensland Police Service. Cr Churchill noted that on behalf of Council and in his volunteer capacity as the President of the Gladstone Region Qld Retired Police Association and a State Vice President ex-officio, to hear of this sad tragedy to our brave Queensland Police officers and members of the public was very tragic. Cr Churchill noted that every officer and every worker deserves to go home safe, well and alive after their rostered duty.

Cr Churchill noted that every time we hear of these tragic incidents that occur, our emergency services personnel always reflect back on their own service and remember those close calls. Cr Churchill further noted that as every good law-abiding person would know, that if you hurt one, you touch or hurt most of us. Cr Churchill expressed prayers and deepest sympathies to their families, friends and work colleagues. Cr Churchill noted that the brave officer's funeral service will be with full state honours and will be held tomorrow (Wednesday 21 December 2022). Cr Churchill mentioned that this is never good news at any time, especially before the festive season. Cr Churchill mentioned that today is an opportunity for Council to honour their bravery and a responsibility for everyone to remember and celebrate their lives. May they rest in peace. Cr Churchill gave an impassioned reminder message: that as we go into the festive season, to all of the emergency services personnel we really really do thank them for what they do and can't emphasise it enough for them to "Take Care and Stay Safe".
