

Comments provided as part of the Animal Management Local Law & Subordinate Local Law Proposed Amendments 2023 Online Survey

Submission Period: 22 March 2023 to 12 May 2023

1	The biggest issue faced is people doing the right thing being harassed by people doing the wrong thing when rules are put in place. We have a small dog that has been attacked by another dog quite savagely, we no longer walk on the beach unless we both go. I have been jumped on more than once and been told while walking with a friend that the northern end of Agnes is a dog's domain while a lady held onto her dog so it would not attack us. But I have also seen people with dogs that they have off the lead and they do not leave their owners side. I walk the beach daily and monitor turtles at the northern end which is conservation and nation park and have witnessed the distinction caused by some. Please what ever is decided ensure it is closely monitored
2	Regardless of which areas are designated on leash/off leash (the irresponsible dog owners in Agnes Water don't care) the bigger issue should be ensuring the safety and the ability of beach goers to peacefully enjoy the beach without risk of harassment by unleashed dogs and the ignorance of their owners who believe the beaches are there sole domain. Therefor policing of and enforcement of any changes are paramount otherwise these changes are pointless.
3	Dog status of areas should be signed as it is confusing for visiting dog owners (tourists). Eg When walking my dog at Wild Cattle Ck, tourists ask me if 1. Are dogs allowed on the beach area?, 2 On or off leash? I understand it is covered in your rules online, but is it reasonable to expect tourists to search for it? (often difficult to find info when familiar with your internet site). Signage at this point should also advise dog status of Canoe Pt. I feel discriminated against when there are only basic facilities provided for dog owners eg only two uncovered tables and no electric/gas BBQs provided in the dog permitted southern end of Tannum Esplanade. I greatly appreciate the dog off lease designation of Canoe Pt beach and it is very important to maintain dog access to (the mainland side of) Wild Cattle Ck for residents but particularly for tourists who are allowed dogs within the Caravan Park. More attention needs to be placed on refilling (or providing more) dog poo pickup/disposal bags. Dog owners are asked to be responsible and pickup their dog's poo but often no bags are available. (I take bags with me but unfortunately there can be more than 2 poos on one walk - and sometimes other dogs' poo to pick up requiring extra bags). I wonder what the value of the survey is given Council have already adopted the changes? Per your timeline below, there is no provision to revise their decision, merely collate results. Community Engagement should occur BEFORE the decision has been made. I suspect this survey is merely a means of informing the public of the new rules while giving people the feeling they have had a say.
4	I believe we should follow suits with other states and have a single fee for a pet registration that lasts the life of the pet
5	More dog parks needed. More dog off leash areas needed in calliope. More shade needed at all dog parks - we live in CQ and this should be a priority to everyone.

6	I would like to see mandatory notification of neighbors when using insecticide for insect
	infestations, to allow native bee keepers the opportunity to close their hives as a
	protective measure. Suggest at least 24 hours notice.
7	As a responsible owner of two beautiful large German shepherds I am strongly against any
	loss or restriction of dog off leash areas in the tannum sands area. Our girls are friendly
	and require regular exercise and socialisation to keep them healthy. In fact I don't think
	there are enough dog friendly areas in our region, not to mention dog friendly camping
	locations. Cattle Island and cattle Creek especially are great areas for dogs to swim and
	run while maintaining distances from local swimmers and other dogs in the area.
8	I am sick to death of unruly dogs on main beach in the swim area off leash. It is common
	for people to have 2 or more dogs off leash. You cannot put your towel down for fear of it
	being urinated on. It is a problem right up to Atlantis Blvd beach access. There are signs
	but these dog owners ignore them. Agnes needs a permanent ranger.

18	None of these restrictions mean anything if there is not the enforcement and fines to back
	it up, If there are no boots on the grounds then new (and old) laws and policies are
	nothing but words on paper that many people ignore and that is very evident when it
	comes to dogs on and off leashes in areas they are not supposed to be.

	well-behaved dogs under "voice command" into more public areas in the Gladstone
	region. It will still allow you to penalise owners of dogs misbehaving or causing problems
	in such areas.
34	Dogs need to be prohibited totally on Chinamens beach due to irresponsible owners
34	during turtle nesting season.
35	I don't believe restricting dogs off leash beaches is appropriate. As a regional area we can provide safe areas for people to walk their dogs and give dogs a chance to run. This in turn actually provides stimuli for dogs and is a preventative measure in reducing noise complaints. By restricting access you a further contributing to animal control issues. We have enough beaches and parks in regards to our regions population size that having open and numerous off leash areas for dogs to be walked is actually not an issue. All of Tannum and Boyne area should be an open off leash area. It is one the main central locations within Gladstone region and we should not be making it harder for animal owners and their dogs to be safe and healthy. In fact many larger councils have instead taken the step
	to be more animal inclusive this has a flow on effect that actually contributes to
	preventing loneliness in elderly, increased physical activity of the community thus
	decreasing demand on public health. Providing bins and dog bags, good signage in
	reminding dog owners how to safely be off leash should be enough.

48	I would like to see Tannum Sands Milliniun Esplanade to be dogs on leash, on foot path at
	all times. I would also like to see Tannum Sands beaches to be available for dogs between
	the hours of 5 pm and 8 am. The beaches are usually void of families in those times. GRC
	need to look at becoming a more dog friendly region as we have the reputation of being
	the MOST DOG UNFRIENDLY REGION in Australia with our visiting travellers to the point of
	them avoiding this area. I am a rate payer and a dog owner, I would like to see our towns become so much more pet friendly perhaps GRC could look at other regions that have got

	they have a litter, too many backyard breeder can just get a licence and cover themselves
	with a breeders licence that has no rules to being controlled on being a breeder or rules
	on being maintained as one. Also they have no consequences if they lie to buyers and
	cannot afford to take them to court. Breeders need to be controlled more. We pay alot for
	pets now i think breeders need to feel the rules have more hold on them then having no
	rules. More need to be done about checking in on breeders as well.

	As a community we need to do more somehow.
54	None of the dog off leash area should be expanded. Dogs being taken everywhere is out of control and is an accident waiting to happen, people are not responsible enough with their animals.
55	Please consider having a designated time for dogs to be allowed to be walked on leash along the Millenium esplanade, Tannum sands beach. Eg. not between the hours of 7am and 4.30pm
56	millennium esplanade should be open to on leash dogs on the footpaths only and the beaches before 9am and after 5pm
57	Dog on leash areas to be established along the Millennium Esplanade - on curfew ie before 8am and after 4:30pm. We pay \$6k in rates to live at Tannum Sands but no safe place to walk the dogs along the waterfront. Pour some of those excessive rates in to dog control officers to ensure the curfew is adhered to - give us a safe place to walk our dogs with our kids instead of putting our lives at risk.
58	I think that dogs on tannum beach should be kept on leash until the owner can verbally communicate if their dog is friendly for other dog interactions. If my dog is on a leash I do not want unleashed dogs running up to my dog. My dog was attacked two months ago by an unleashed dog while the owner stood and did nothing.
59	Stop treating dogs as enemies. They are a part of the family for most, detested by few.
60	More recognition of harassment complainers - my neighbour was so prolific in making my life a living hell, and she got away with it. Deliberately antagonising pets to provoke a reaction and then she would lodge a complaint.
61	Maybe look at desexing and microchipping days with discounts, including people without consession cards
62	More must be done about dogs wandering around the streets, maybe fines for insecure fencing. Nasty dogs must be kept away from general dog walking areas.
63	All areas mentioned above should be on leash areas.
64	Off leash beaches are just taking public beaches away from the public. It is unlikely a dog owner has their dog properly trained, unlikely a dog owner has their dog properly dewormed and immunized, unlikely a dog will respond to voice commands from their dog owner, and zero likelihood a dog owner has Canine Liability Insurance. No sane member of the public would ever go into a dog off-leash area, and all off-leash dogs on beaches should be banned.
65	It is rare to see any dog on a leash at any beach in the Agnes Water area, and it is too dangerous for parents to take their children to beaches such as Workman's Beach. Everyday dog owners are taking their dog/s through Joesph Banks Conservation Park, and most of the time these dogs are Off Leash in the conservation park. While dog owners have their dog off leash on most beaches, it is rare to see any dog owner with their dog in the off leash area at the SES grounds. Dogs are wondering on most streets, and it is too dangerous to walk along a footpath, and council patrols are 110% farce.
66	Consideration needs to be taken for older dogs who are unable to access off leash areas on the beach as they are unable to access the areas via the stairs or deep drop off.
67	One of the best things about Agnes Water and 1770 is the off leash dog areas. It's unfortunate that a few irresponsible dog owners are going to jeopardise this honour that we have to enjoy the beaches.

68	Dogs not permitted on the SES grounds during the Rainbow bee-eater nesting season.
	Minimum enclosure for dangerous dogs to be 20sqm.
	Chickens and Guinea fowl to be contained on owners property and not permitted to free
60	range on neighbouring property.
69	If there is a restriction on dogs at SES grounds, there should be no other activities allowed on those grounds Aug to Jan.
70	(I'm not a resident yet; 14 more weeks until I move there).
	Dog off-leash areas need adequate signage demanding that dogs still be UNDER
	EFFECTIVE CONTROL even if not on lead.
	If they cannot be controlled off lead, they must stay on lead regardless of area
	designation.
71	Cats should be kept INSIDE at all times due to the wonderful birds and animals in our area.
72	The council should also look at stricter rules on cat ownership as there are so many feral
	and pet cats roaming at night, and or also a more targeted removal of said cats that are
	outside.
73	I believe there should be no dogs on any beaches in the 1770/Agnes Water area because
	there is no policing of people breaking the rules/law. Maybe the council can build a dog
	friendly
	park for those who want to exercise their dogs in the beautiful outdoors at the SES
	Grounds or Sport and Rec Grounds. Ialso think having cats outdoors should be banned and owners should have enclosures. I have seen quite a number of very large, wild feral cats in
	our neighbourhood, which has an abundance of birdlike, echidna, wallabies etc.

` `	Grounds at any time: just as dogs are also prohibited within National Parks and
	Conservation Parks where these ground nesting birds also build their burrows in sand,
	easily disturbed by curious dogs.
	-All rental properties adjacent to the Joseph Banks Conservation Park should by
	regulation, be declared dog and cat disallowed, because dogs/cats are now frequently
	observed straying unsupervised into this natural environment, harassing kangaroos, scrub
	turkeys, goannas etc.
	-Having any dog on any beach (on or off leash) in the Town of 1770 and Agnes Water area,
	northern end of the Agnes to Round Hill Head beach adjacent to the Joseph Banks

	-No dangerous dogs should be allowed in any suburban areas. Who decides if a dog is
	dangerous or notdoes this happen after a traumatic event?
75	1. There should be a ban on dangerous dogs in suburban areasto marry in with the last
	statement.
	2. In the 1770/Agnes Waters area, I believe there should be a ban on all dogs on all
	beaches in this area. The reasons beingwe have had a place of residence in this area for
	over 40 years and have seen these rules change wrt 'dogs on beaches' many times in the
	period of time stated. What happens, particularly now, is that the rules are flouted by
	many people and there are dogs on any beach at any time, mostly not on leashes. Second
	reason being, that a rule/law may be set in place, but it is rarely overseen/put into force.
	So those breaking the rules wrt to 'dogs on beaches' are never held to account for their
	wrongdoing. The ranger is never available to oversee the problem, either at another

	location, or the breech is in out of 'ranger' work hours, or the offenders are given a 'warning;' instead of a fine straight up, they know the rules. If rules/laws are set in place and fines imposed for those flouting the rule/law a heavy fine should be imposed, in the vicinity of \$250.00-\$500.00, then this may serve as a deterrent to breaking the rule/law. This can only be set in place if there is someone employed to enforce these rules/laws. 3. There should definitely NOT be dogs allowed at the top end of Agnes Beach adjacent to the Joseph Banks Environmental Park as there are many fragile ecosystems in this area that need preserving. How would this law/rule be enforced? Dogs off leashes, or in fact dogs, have the propensity to destroy the beach and dune ecosystems. A total ban is the only way to save this area from more man-made destruction. To state a fact, we observe renters coming to pet friendly accommodation, and once the dogs are let out of the car and off their leashes they have a great time chasing the kangaroos, wallabies and echidnas to name but a few. Something, I would love to see stopped by introducing a law that states all short term accommodation (that is in the vicinity of Joseph Banks Conservation Park) be non-pet friendly. 4. The 1770 SES grounds should be dog free all year round, no dogs at all as there are other animals (as well as the rainbow bee eaters) in this vicinity that need to be protected from domestic dogs. To state the obvious, wild animals that we have no control over are a problem and also needs addressing eg foxes, wild cats and wild dogs.

	areas - only in rural areas, to ensure that people and animals are kept safe.
