#### **Purpose:**

To allow Council to set a date and time for future meetings in accordance with s256 of the *Local Government Regulation 2012.* 

#### Officer's Recommendation:

#### That Council:

- 1. Hold its first General Meeting for the 2024 election term on Tuesday 23 April 2024; and
- 2. Adopt the General Meeting schedule of the first and third Tuesday of each month, commencing 7 May 2024.

#### **Summary:**

Section 256 of the *Local Government Regulation 2012* provides that Council must set the time and date for future meetings at the Post-election Meeting.

General Meetings have previously been held on the first and third Tuesday of each month.

To accommodate current meeting procedures in Council's Council Meeting Procedures Policy, it is recommended that the first General Meeting of the newly formed Council be held on 23 April 2024. The following meetings can then commence in-line with the recommended meeting schedule of the first and third Tuesday each month. Reports will be due for the 23 April 2024 meeting by 11 April 2024.

Council may at its discretion elect to resolve in favour of an alternate meeting schedule provided that Council satisfies its legislative requirement to meet at least once per month.
