- My dog is not a restricted breed (i.e. Dogo Argentino, Fila Brasileiro, Japanese Tosa or of the type commonly known as 'American Pit Bull Terrier' or 'Pit Bull Terrier') or any crossbreed thereof
- I acknowledge that I am over 18 years of age and understand I am now responsible for the animal/s listed and am liable for any fees, charges, penalties, restrictions, conditions, fencing/enclosure requirements, and all ongoing registration responsibilities
- I confirm the property where the animal is kept is not a vacant allotment, i.e., there is currently an occupied residence on the property, and the property has a suitable enclosure and/or adequate fencing to prevent my animal(s) from escaping
- I acknowledge that the registration period is from the 1 November to 31 October
- I acknowledge that Council reserves the right to refuse registration due to non-compliance with Council's Local Laws and compliance action may commence

Privacy Act Personal Information Collection Notice

Gladstone Regional Council is collecting your personal information and that of the alternate emergency contact person to process your application for new animal registration or transfer of registration from another local government area. Council is authorised to do this under Local Law No.1 (Administration) 2011, Local Law No.2 (Animal Management) 2011, Local Government Act 2009 and Animal Management (Cats & Dogs) Act 2008. The information collected will be entered into Gladstone Regional Council's names and address database and may be used for any necessary Council business. The information will only be accessed by authorised Council employees. Some of this information may be given to a person who finds your animal and wishes to return it to you. This information will not be given to any other person or agency unless you have given us permission, or we are required by law.
