- Term Minimum 3 years
- Total investment opportunities: \$150,001 + per year

2. Goodwill Partner

- Term Minimum 3 years
- Total investment opportunities: \$75,001 to \$150,000 per year

3. Diamond Sponsor

- Term Minimum 3 years
- Total investment apportunities: \$30,001 to \$75,000 per year

4. Platinum Sponsor

- Term 1-2 years
- Total investment opportunities: \$15,001 to \$30,000 per year

5. Gold Sponsor

- Term Negotiable
- Total investment opportunities: \$5,001 to \$15,000 per year

6. Silver Sponsor

- Term Negotiable
- Total investment opportunities: under \$5,000 per year
