The Gladstone Green Metals and Industry Workshop and Community Forum was held on Wednesday 6 August 2025. Thank you, Councillor Simon McClintock, Councillor Mellissa Holzheimer, Councillor Natalia Muszkat and Councillor Leanne Patrick for attending those events because it's very important that we keep involved in our major industry workshops and I look forward to encouraging more industry development in the Gladstone Region.

On Saturday 16 August 2025 we had the Art Science Innovation Festival. Thank you, Cr Patrick, for attending. And we had the First5Forever Teddy Bears Picnic at the Tondoon Botanic Gardens on Wednesday 6 August 2025 which is always a popular event with the younger generation. Thank you, Councillor Karen Davis, for attending that event.

Yesterday, 18 August 2025, was Vietnam Veterans Day and we acknowledge our Vietnam Veterans right across the region. I spoke with a few of our Vietnam Vets yesterday at the Gladstone service and as I've said a number of times at the services, the soldier on top of our cenotaph in Gladstone is to represent a Vietnam Veteran, which is very appropriate considering how poorly they were treated when they returned home to Australia. It's nice that we can acknowledge their services to our Country and to the world.

The Gladstone Region Show Holiday was on Monday 11 August 2025. I know we've locked in the August show holiday as the Monday of the Ekka for the rest of this term, so it's not going to change this term, but I think it will be discussed again because at some point we need a show holiday that is regionwide. As long as the Wide Bay education system celebrates a different show holiday, we are not including the whole region, so it's something we need to think about. For beyond 2028, we need to start working on how we can get Education Queensland to come on board so we can have a Show Holiday that is from Rosedale to Raglan to Many Peaks and everywhere in between.

Upcoming events we have the 31st Golding Showcase: Port Curtis Callide Valley Youth Art Exhibition on Friday 22 August 2025 at the Gladstone Regional Art Gallery and Museum (GRAGM). That will be a fantastic showcase as it's all our younger generations artwork on display.

The Port to Park Fun Run is on Sunday 24 August 2025 and I know Councillors are either volunteering or participating. We have our Community Investment Program Road shows that are commencing around the region. The Mount Larcom Community Forum is on Saturday 30 August 2025.
