




PLANNING APPLICATION APPROVALS 2010-2014










OPERATIONAL WORKS LODGEMENT 2010-2014







OPERATIONAL WORKS APPROVAL TIMEFRAMES - AVERAGE NO. OF DAYS FOR DECISION




TOTAL APPROVALS & TIMEFRAME (%)




RATES SEARCHES 2011-2014




BUILDING SEARCHES CONDUCTED 2009-2014




TOTAL BUILDING & PLUMBING APPROVALS




TOTAL DWELLING APPROVALS




TOTAL UNIT/DUPLEX APPROVALS (NO OF UNITS)




TOTAL HOUSING UNIT APPROVALS (DWELLING, DUPLEXES, UNITS)




BUILDING APPROVAL TIMES - FROM 1 JULY 2013




PLUMBING APPROVAL TIMES - FROM 1 JULY 2013




BUILDING & PLUMBING APPROVALS - WITHIN REGULATORY TIMEFRAMES - FROM 1 JULY 2013
