




#### **PLANNING APPLICATIONS LODGED 2010-2015**




#### **PLANNING APPLICATION APPROVALS 2010-2015**






#### **NUMBER OF OPERATIONAL WORKS APPLICATIONS LODGED - 2015**



#### **\$ VALUE OF OPERATIONAL WORKS DEVELOPMENTS LODGED - 2015**




#### **NUMBER OF OPERATIONAL WORKS DECISIONS MADE - 2015**








#### **TOTAL BUILDING & PLUMBING APPROVALS**




#### **TOTAL DWELLING APPROVALS**




### TOTAL UNIT/DUPLEX APPROVALS (NO OF UNITS)




## TOTAL HOUSING UNIT APPROVALS (DWELLING, DUPLEXES, UNITS)






#### **BOUNDARY RELAXATION APRROVALS**




