




PLANNING APPLICATIONS LODGED 2010-2015




PLANNING APPLICATION APPROVALS 2010-2015






NUMBER OF OPERATIONAL WORKS APPLICATIONS LODGED - 2015



\$ VALUE OF OPERATIONAL WORKS DEVELOPMENTS LODGED - 2015




NUMBER OF OPERATIONAL WORKS DECISIONS MADE - 2015








TOTAL BUILDING & PLUMBING APPROVALS




TOTAL DWELLING APPROVALS




TOTAL UNIT/DUPLEX APPROVALS (NO OF UNITS)




TOTAL HOUSING UNIT APPROVALS (DWELLING, DUPLEXES, UNITS)






BOUNDARY RELAXATION APRROVALS




