






### PLANNING - % WITHIN TIMEFRAME & AVERAGE NO. OF DAYS FOR DECISION




#### **TOTAL BUILDING & PLUMBING DECISIONS**




#### **BUILDING DECISIONS - % WITHIN TIMEFRAME & AVERAGE NO. OF DAYS FOR DECISION**




### PLUMBING DECISIONS - % WITHIN TIMEFRAME & AVERAGE NO. OF DAYS FOR DECISION




### **BUILDING & PLUMBING DECISIONS BY APPLICATION TYPE SEPTEMBER 2017**




### **BUILDING & PLUMBING DECISIONS BY SUBURB SEPTEMBER 2017**








